ORDINANCE NO. 2001-21

Enacted on the 27th day of November, 2001

AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF AN ALLEY ADJACENT TO LOTS 6 AND 7 IN BLOCK 10 IN THE ORIGINAL SURVEY OF HANNA, INDIANA

WHEREAS, THE FIRST LUTHERAN CHURCH OF HANNA, INC., formerly known as GERMAN LUTHERAN CHURCH OF HANNA has filed a petition with the LaPorte County Board of Commissioners, under the provisions of Indiana Code 36-7-3-12 and 36-7-3-13 for the vacation of a portion of an unimproved alley that lies between Lots Six (6) and Seven (7) in Block 10, in the Original Survey of Hanna, Indiana, as now located; and

WHEREAS, notice of a hearing before the LaPorte County Board of Commissioners has been published in the LaPorte Herald Argus in its issue of November 14, 2001, said publication being at least ten (10) days before the date of this hearing; and

WHEREAS, no remonstrances to the vacation of said portion of the unimproved alley have been filed with the LaPorte County Board of Commissioners; and

WHEREAS, your petitioners have paid for the costs of publication of the notice of this hearing, as provided by statute; and

WHEREAS, it is desirable and in the best interests of the Village of Hanna, Indiana, to vacate said portion of the unimproved alley (a) because THE FIRST LUTHERAN CHURCH OF HANNA, INC., and MICHAEL K. WRIGHT, and ROBERT H. & JOAN SAUBER own all contiguous property, (b) that the vacation of said portion of the unimproved alley will not materially damage the adjoining property, and will relieve the county (and/or Village of Hanna) of the responsibility of maintaining the same, and (c) will add the property vacated to the tax rolls of the County of LaPorte, Indiana.


NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LAPORTE COUNTY, INDIANA, as follows:

That the portion of an unimproved alley that lies adjacent to Lots Six (6) and Seven (7) in Block Ten (10) in the Original Survey of Hanna, Indiana, is hereby vacated, and in accordance with the law of the State of Indiana, the fee simple title to the vacated portion of the unimproved alley reverts to the adjoining property owners.


