

ORDINANCE NO. 2001-22

**AN ORDINANCE VACATING A PORTION OF
CAROLINE AVE., a/k/a CARLISLE TRAIL,
IN LIBERTY BELL SUBDIVISION IN SECTION 25,
TOWNSHIP 38 NORTH, RANGE 2 WEST,
GALENA TOWNSHIP, LA PORTE COUNTY, INDIANA.**

WHEREAS, Donald A. Kelsch and Florence Kelsch have filed their petition to vacate that portion of Caroline Ave., a/k/a Carlisle Trail, in Liberty Bell Subdivision, in Section 25, Township 38 North, Range 2 West, Galena Township, as recorded in Plat Book 6, Page 34, in the Office of the Recorder of La Porte County, Indiana, from its intersection with Lindbergh (Cherokee) Trail on the East to the westerly line extended of Lot 30 in Block 46 of Liberty Bell Beach Subdivision, which petition was filed on the 31st day of October, 2001, and hearing on said petition was set for November 13, 2001, at 10:00 a.m ; and,

WHEREAS, notice of hearing on said petition was published in the La Porte Herald-Argus on November 2, 2001; and,

WHEREAS, Thomas Lode, the registered owner of Lots 1 through 9 in Block 40 of Liberty Bell Beach, which lots adjoin Caroline Ave., a/k/a Carlisle Trail, has signed his waiver of notice and consent to granting said petition, and,

WHEREAS, notice was mailed by Certified Mail to Donald and Marjorie Fecher, Luke T. Sheridan, Juli Whiteman and Joseph G. and Lisa A. Offerman, the only other registered owners of lands adjoining Caroline Ave., a/k/a Carlisle Trail on the 31st of October, 2001; and,

WHEREAS, pursuant to notice, hearing was conducted by the Board of Commissioners on the 13th day of November, 2001; and,

WHEREAS, no written remonstrances to the granting of said petition were filed, and no persons appeared in person at said hearing to remonstrate; and,

WHEREAS, the Board finds that the petition should be granted

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED AS FOLLOWS



That portion of Caroline Ave , a/k/a Carlisle Trail, as platted in Liberty Bell Beach Subdivision, a subdivision in Section 25, Township 38 North, Range 2 West, Galena Township, as recorded in Plat Book 6, Page 34, in the Office of the Recorder of La Porte County, Indiana, is hereby vacated from its intersection with Lindbergh (Cherokee) Trail on the East to the westerly line extended of Lot 30 in Block 46 of said Liberty Bell Beach Subdivision, La Porte County, Indiana


2. This ordinance shall be in full force and effect from the time of its passage.




