Open Reassessment Bids

Mr. Willoughby, we have received three bids for the reassessment from The Nexus Group, A & S Associates and Tyler Technologies; all of which are sealed, marked and received by the deadline imposed by the Assessor of last Friday. The first bid is the Nexus Group for \$2,116,000.00 with a 15% retainage in lieu of a bond which was included in the bid specifications. The next bid is from A & S Associates and their proposed fee is \$1,670,000.00. It provides for a retainer in lieu of a bond. Last, we have Tyler Technologies for \$1,825,400.00 it appears they have posted a bond all of which is in compliance with the bid specifications.

Mr. Layton made a motion to approve, seconded by the chair, motion carried by voice vote 2-0.






