COMMISSIONER'S COMMENTS

Mr. Layton, I wish everyone a Merry Christmas and a Happy New Year.

Mr. Bohacek, after our last meeting, I was greeted with my morning News Dispatch. I got to read Mr. Friedman's and Mr. Milsap's retort about how we handled the contract for our legal services. Mr. Milsap was concerned that I took a vote on a contract towards the end of my term and that it would be a contract that would extend beyond my term. I would suggest that Mr. Milsap read a government book because government entities typically do vote on contracts that extend beyond the term of any elected official. However, what Mr. Milsap doesn't understand and what the public should understand; the board that he serves on, the Michigan City Common Council, does in fact end at the end of the calendar year, because the entire board is elected – there is no carry over terms. In conclusion of their November 7, 2007 meeting, Mr. Milsap, serving as president, allowed his board to continue the contract with their attorney, Attorney Meyer, through the course of the 2008 calendar year. Of that board make up at that time, four members were not returning, not retained by the voters. Maybe Mr. Milsap, as the president, should have halted that action. He chose not to and now here we are a few years later and he is calling foul ball. Mr. Milsap is claiming that this is a retaliatory effort. "Mr. Milsap believes Commissioners left him out of the vote in retaliation for his saying he wouldn't accept the county's gold plated health insurance until discussed publicly and approved at a public meeting since it isn't available to other part time employees." Mr. Milsap, of course, wouldn't take our county health insurance, he is a fireman. His fire insurance is a \$1 a month. Why would he take ours when it would cost him a couple hundred dollars more than that; that would be stupid. Of course he is not going to take our county's health insurance. It was not in retaliation in any way shape or form it was just the county commissioners trying to stop this badgering by Attorney Friedman to be reappointed to the spot as county attorney. What is also interesting is that Mr. Milsap, whose personal attorney is Mr. Friedman, – Mr. Friedman says he served as county attorney for twenty years, he claimed this issue never came up while he was here. If he served us for twenty years, and the commissioners have been getting county health insurance for more than twenty years, why did he choose to withhold this advice? He has no problem popping off with advice, comments and suggestions

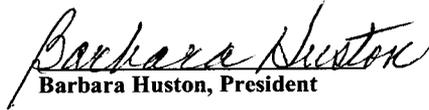

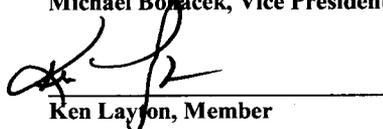

RESOLUTION TO ACKNOWLEDGE EXEMPLARY BEHAVIOR

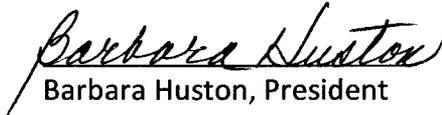
WHEREAS, the Board of Commissioners of the County of LaPorte are authorized to recognize certain individuals for their actions.
