A summary of the Subject matter contained in the proposed amendment to the Joint Zoning Ordinance of LaPorte County as set forth in Table 07.02/ Appendix "Schedule of Permitted Uses" set forth below, are as follows:

- (1) Deletion of "Adult book and video stores"
- (2) Deletion of "Adult Regulated Use"
- (2) Add "Sexual Oriented Business"
- (3) "Massage Establishments" permitted uses shall be subsequent to Section 14.09(a).

The proposed JZO provide for the regulation of sexually oriented businesses in order to promote the health, safety, and general welfare of the citizens of LaPorte County, and to establish reasonable and uniform regulations to prevent the deleterious secondary effects of sexually oriented businesses within LaPorte County.
