**AN ORDINANCE ESTABLISHING ADDITIONAL
PAYMENTS TO THE SWANSON CENTER**

WHEREAS, the Swanson Center provides critical services for the betterment of LaPorte County residents and is funded in part by the La Porte County government, as provided by Ind. Code Chapter 12-29-2; and,

WHEREAS, Ind. Code Chapter 12-29-2 provides for increased funding from the County, which LaPorte County has not provided for the years from 2005 to 2012, totaling Three Hundred Seventy-Two Thousand, One Dollars (\$372,001.00) in additional funds that could have been paid to the Swanson Center over that period;

WHEREAS, there was a lack of clarity in both billing by the Swanson Center and payment by LaPorte County. As a result, the Swanson Center and LaPorte County have come to an agreement that Swanson Center shall receive Three Hundred Thousand Dollars (\$300,000.00) as full and final satisfaction of all amounts claimed prior to calendar year 2013; and,

WHEREAS, LaPorte County Council appreciates the benefit the Swanson Center provides to the County and wishes to support Swanson Center's operations; and,

WHEREAS, the LaPorte County Riverboat Fund has sufficient funds to provide additional support to Swanson Center,

NOW, THEREFORE, BE IT ORDAINED BY THE LA PORTE COUNTY COUNCIL:


Section 1. That La Porte County hereby resolves to pay \$300,000 from the La Porte County Riverboat Fund (Fund 1191), to the Swanson Center, in addition to the regular budgeted funds paid by the County to the Swanson Center.

Section 2. That said additional funds will be paid in increments of One Hundred Thousand Dollars (\$100,000.00) from the La Porte County Riverboat Fund, with the first One Hundred Thousand Dollars (\$100,000.00) payable in the Second Quarter of 2013, another One Hundred Thousand Dollars (\$100,000.00) payable in the Third Quarter of 2013, and the final payment due in the Fourth Quarter of 2013.

Section 3. That the Three Hundred Thousand Dollars (\$300,000.00) to be paid to Swanson Center will be a full and final settlement of any arrearages alleged to be owed to the Swanson Center by the La Porte County Council for the calendar years 2005 through 2012.




NOW, THEREFORE, BE IT ORDAINED BY THE LA PORTE COUNTY COUNCIL:

Section 1. LaPorte County Council Ordinance 2012-05 is hereby amended as follows:


