ORDINANCE NO. 2014-4**

**ORDNANCE AUTHORIZING THE ALLOCATION AND SUBSEQUENT
DONATION OF MONIES TO PURDUE NORTH CENTRAL**

WHEREAS, Purdue University North Central (“PNC”) came before the LaPorte County Council on January 29, 2014 at the Council meeting and discussed the need for a new Student Services and Activities Center; and,

WHEREAS, PNC presented the Council with the “Request by Purdue University North Central for Contribution towards a Student Service and Activities Complex”; and,

WHEREAS, attached to said request was a petition with over fifty (50) signatures of freeholders and taxpayers of LaPorte County in support of the donation request, pursuant to Indiana Code §36-1-18-1; and,

WHEREAS, PNC is asking for a donation amount not to exceed Twenty Five Thousand Dollars \$25,000 pursuant to Indiana Code §36-1-18-1; and,

WHEREAS, the LaPorte County Council, deemed it prudent to financially assist PNC in their fund raising efforts to construct a new Student Service and Activities Complex; and,

WHEREAS, at the LaPorte County Council meeting on March 24, 2014, Councilman Earl Cunningham put forth a motion to allocate all Twenty Five Thousand Dollars (\$25,000) from the Win Tax Fund for this year, for future payments beginning December 1, 2014; and,

WHEREAS, the LaPorte County Council will donate Five Thousand Dollars (\$5,000) a year from the Twenty Five Thousand Dollars (\$25,000) allocated in 2014, for the next five (5) years to PNC, beginning December 1, 2014;

NOW THEREFORE BE IT RESOLVED that the LaPorte County Council, LaPorte County, Indiana hereby declares as follows:


1. The County Council will allocate Twenty Five Thousand Dollars (\$25,000) from the Win Tax Fund in the calendar year 2014 for future donations to PNC.
2. This donation to PNC will begin in December 1, 2014 with a payment of Five Thousand Dollars (\$5,000), and a payment will be made each December thereafter for four years, for five (5) total payments, for a total amount of Twenty Five Thousand Dollars (\$25,000).

3. This donation to PNC will be designated solely for PNC's new Student Services and Activities Complex.
4. This donation request does not exceed Twenty Five Thousand Dollars (\$25,000) as is pursuant to Indiana Code §36-1-18-1.

This Resolution is to take effect immediately upon passage by the LaPorte County Council.
